pepe.team respects your privacy and is committed to protecting your personal data according to the provisions of this Privacy Notice ("Notice"). This Notice is the essential part of the Terms of Service

This Privacy Notice aims to give you information on how Pepe Team ("we", "Company") collects and processes your personal data through your use of the Software platform and/or its Services. It is located on the Website: **pepe.team**

It is important that you read this Notice together with any other privacy notice/pop-ups we may provide on specific occasions when we are collecting or processing personal data about you so that you are fully aware of how and why we are using your data.

We may update this Notice from time to time. The updated version will be indicated by the date of the last update above. If we make material changes to this Notice, we may notify you by posting the Notice on the Website. We encourage you to review this Privacy Notice frequently to be informed of how we are protecting your information.

We do not collect logs of your activity, including no logging of browsing history, traffic destination, data content, or DNS queries. We also never store connection logs, i.e., no logs of your IP address, your outgoing VPN IP address, connection timestamp, or session duration. We designed our systems not to have sensitive data about you; even when compelled, we cannot provide data that we do not possess. We do not collect your seed phrase or wallet address. It is stored on your device, and we do not have any access to it.

As you interact with our Software platform and/or Services, we may automatically collect technical data about your equipment, browser features, browsing actions and patterns, but it collects anonymously. Aggregated Data such as statistical data, anonymous customer behavior data for any purpose. However, Aggregated Data is not considered personal data as this data does not directly or indirectly reveal your identity. For example, we may aggregate your Usage Data to calculate the percentage of users accessing a specific website feature.

You can set your browser to refuse all or some browser cookies, or to alert you when the Website or Services set or access cookies. If you disable or refuse cookies, please note that some parts of the Website or Services may become inaccessible or not function properly.

We also do not knowingly collect data relating to children. If we learn that any personal information of anyone under the age of 18 has been collected, we will take the reasonable measures to promptly delete such data from our records.
